**ACKNOWLEDGEMENT OF THE FINANCIAL REGULATIONS 2021-2022**

I, the undersigned ....., parent of the student ..... declare, by the present document, that I have read the financial regulations of the school, given at the time of my child's registration, and accept the conditions, in accordance with article 1 of these regulations..

I also declare, for information purposes, to register my child at school for the following period: from.....to.....

According to article 5 of the financial regulations, any pedagogical term started is due. Within this framework, here are, for the year 2021/2022, the dates of the pedagogical trimesters and payment dates:

- Academic Term 1: From August 31 to November 28, 2021 - Payment due by August 15, 2021
- Academic Term 2: From November 29, 2021 to March 20, 2021 - Payment due by November 26, 2021
- Academic Term 3: From March 21 to July 1, 2022 - Payment due by March 18, 2022

According to article 3, with this registration, I commit myself to pay all the school fees described in the quotation, attached, including the school construction/maintenance fees of 2 000€ per child. These are payable in one installment. However, the school offers the possibility to parents, who request it, to pay in several installments. This amount is due from the moment I enroll my child in the school, regardless of the duration of the schooling.

I inform the school that tuition fees will be paid by (check the appropriate box) :

- By myself, legal representative of the child
- By the following entity....., although these fees are my responsibility.

I choose the following tuition payment frequency

- Pay all at once for the whole school year
- By term instalments, in accordance with the above-mentioned deadlines
- By monthly instalments, before the 5th of each month, including a 5% overall increase of the invoice

In accordance with Article 7 of the Financial Regulation, payment deadlines not respected will be penalized by a 10% surcharge on the amount due. Failure to pay a due date within one month will subject my child to exclusion from school, reinstatement being conditional upon payment of the debt.

I am therefore aware of the importance of reporting any delay or financial difficulties to the school's financial department, otherwise the increases provided for in the regulations will be automatically and strictly applied.
